- Nonprofit Organizations



CLINICS & EXTERNSHIPS Clinics

UBalt Law clinic students represent clients under the supervision of our world-class clinical faculty. When you enroll in the clinical program, you'll learn to be a lawyer in a way you couldn't through classroom work alone. You will meet with clients, research their cases, advocate on their behalf, and plan how best to meet their legal needs. Our clinics provide assistance to clients involved in civil, criminal and business-related situations.

Externships

The UBalt Law Externship Program engages students in real-life experiences with practicing lawyers and judges. Externships promote the development of key competencies such as legal analysis, research and writing, interviewing and counseling, negotiation, policymaking and advocacy.

Our faculty are leaders in their areas of law, as evident in their scholarship, lectures, symposia, and public appearances. At the same time, they know the importance of being available to their students. JUDICIARY **Judicial Externship**

Externing with a judge is an excellent opportunity to learn about judicial decision-making, hone writing skills, and develop a personal relationship with a judge. Judicial externships are especially valuable to students who are considering a post-graduate judicial clerkship.

Placements may include state or federal court judges or administrative law adjudicators at various state and federal agencies.

Judicial Clerkship

The University of Baltimore School of Law ranks among the top schools nationwide for the number of graduates securing judicial clerkships, consistently sending between 20 and 25 percent of each graduating class into these coveted positions at both trial and appellate courts. It helps, of course, that so many University of Baltimore alumni are represented in the Maryland judiciary many serving on the bench and many more working behind the scenes.

CO-CURRICULAR & EXTRA-CURRICULAR Student Organizations and Diversity Council Extracurricular Programs

There are a number of ways to get involved outside of the classroom at UBalt Law. Our active student population leads and participates in a variety of co-curricular and extracurricular activities, formed around academic and career interests, ethnic background, and more.

Law Review

The Law Review journal operates as a training ground for its members, providing an opportunity for students to hone their writing, research, editing and time-management skills - skills that are prized in the job market.

Law Forum

The Law Forum journal provides a unique focus on Maryland's legal decisions and issues, providing practitioners and the larger community with a reliable source for gaining insight and information on the changes shaping the practice of law in Maryland.

The Diversity Council, comprising 13 student representatives from a variety of our student organizations, is a space where students can bring not only their feedback or concerns, but also ideas and solutions. The DC celebrates the diversity that exists at the law school and highlights initiatives that foster an inclusive community.

Moot Court and Trial Teams

Our teams compete annually in advocacy focusing on wide-ranging

involvina civil rights, constitutional and criminal procedure, international law. and potential legal issues to be heard before the Supreme Court.

FLEXIBLE PROGRAMS

Full-Time Day

- Students take 13–16 credit hours per semester
- Classes are 4–5 days per week
- Classes are typically between 9am-4pm

Part-Time Day

- Students take 9–12 credit hours per semester
- Classes are 3–4 days per week
- Classes are typically between 9am–4pm
- Students are mixed in with full-time students.

Part-Time Evening (Hybrid)

- Students take 9–12 credit hours per semester
- Classes are 4 nights per week (two nights in person, two nights online)
- Classes are typically between 5:45–9:35pm

CONCENTRATIONS AND PRACTICE TRACKS

A concentration comprises substantive or doctrinal courses in a particular area of the law. Practice tracks combine these courses with practical activities like externships, moot court, and co-curricular activities to develop the skills necessary for practice in a particular area of the law.

LIBRARY AND STUDY SPACES

The law library is located on six levels of the Angelos Law Center. There are 24 group study rooms, two computer labs, and hundreds of individual spaces for studying throughout all six floors, plus access to three outdoor terraces for a breath of fresh air when a break is needed.






