





In 2006, Amy Klobuchar became the first woman elected to represent the State of Minnesota in the United States Senate.

Before being elected to public office, she was the leading advocate for successful passage of one of the first laws in the country guaranteeing 48-hour hospital stays for new mothers and their babies.

In 1998, after serving as a partner at two of Minnesota's leading law firms, Klobuchar was elected to serve as the prosecutor for Hennepin County, which includes Minneapolis and 45 suburbs. During her eight years as County Attorney, she made the prosecution of violent and career criminals her top priority. Klobuchar was a leading advocate for successful passage of Minnesota's first felony DWI law, for which she received a leadership award from Mothers Against Drunk Driving.

Since arriving in the Senate, Klobuchar has been a strong advocate for middle-class families on the critical issues facing our nation, promoting long-term economic growth and job creation, bringing fiscal responsibility and accountability to Washington, developing homegrown energy and supporting Minnesota businesses, workers and farmers.

At the national level, Klobuchar took the lead to pass the most significant consumer product safety legislation in a generation, keeping foreign toxic products off our shores and out of our stores, and helped push through a new law to protect children from unsafe swimming pools.

Klobuchar was valedictorian of her Wayzata High School class. She graduated magna cum laude from Yale University and the University of Chicago Law School. She is married to John Bessler, a Minnesota native and a professor at the University of Baltimore School of Law. Their daughter, Abigail, began her junior year of high school last fall.
