After nearly 20 years of supporting chronically absent students and families in Baltimore City and across Maryland, the Truancy Court Program (TCP) has changed its name! Beginning in the 2023-2024 school year, what was once known as the TCP is now the Tackling Chronic Absenteeism Project (TCAP). CFCC has moved away from the language of "truancy" because it implies that students are missing school due to their defiance or their negligence. Data we collected showed that for many of our TCAP students, the root causes of the absences had nothing to do with their defiance or failure to prepare. Despite the new moniker, the program remains the same – a non-punitive, holistic, and restorative approach to addressing chronic absenteeism in Baltimore City Public Schools (City Schools). During the Fall 2023 Session, TCAP operated in six City Schools, including one elementary school, three elementary/middle schools, and two high schools.

The Fall 2023 session kicked off with Orientations at each of the six schools in mid-September. During the Fall 2023 session, the TCAP Team served 78 students and families. The TCAP Team consists of a Coordinator, Mentor, Case Manager, and Attorney. Each weekly session includes checkins with a volunteer judge, restorative circles, and academic tutoring from staff or UBalt students. Throughout the week, members of the TCAP Team work diligently to address any individual or systemic issues that are uncovered in the weekly check-ins, phone calls, texts, and restorative circles. While the issues impacting truancy are myriad, barriers that frequently affect our families include housing insecurity, transportation, food insecurity, violence, trauma, and parental incarceration. Throughout the Fall 2023 session, the TCAP

Team facilitated over 590 individual conversations with TCAP students, the TCAP Team, and the volunteer TCAP Judge; reached out to parents/caregivers on over 2,695 occasions; facilitated 72 restorative circles; provided 12 tutoring sessions to 23 discrete students; provided over 225 resources, including food, clothing, alarm clocks, books, etc.; offered 47 referrals with a total of 211 follow ups for those referrals, and assisted with 15 legal matters with a total of 116 follow ups for those referrals.

Students who successfully fulfill all program obligations and requirements graduate from the program culminating in graduations held at each school beginning in mid-December. TCAP changed its graduation metrics to better align the program with City Schools' chronic absenteeism efforts. Historically, students graduated from the TCP, if they demonstrated a 65% decrease in absences nd/or tardies. Schools are now focusing

a on "attendance rates." As a result, students graduate from the TCAP when at least one of the following conditions is met:

- 1. The student improves their attendance rate by at least 10%, when comparing attendance during the TCAP against attendance in the prior two guarters;
- 2. For those students where attendance data from the prior two quarters is not available, the student has an attendance rate of at least 85% while participating in the TCAP
- At the discretion of the TCAP Judge in consultation with the TCAP Team.
   Discretionary authority provides an opportunity to "graduate" those students whose pre-TCAP attendance rate was 91% or higher and thus could not mathematically improve by 10%, but who demonstrate improved attendance, academic achievement, and attitude towards school attendance.

Applying the metrics stated above, 62 of the 78 students (79%) successfully graduated from TCAP. Historically, the TCP typically attained a 70-75% graduation rate. Graduation rates were lower, however, during Covid's period of virtual learning, as well as directly after the return to "in-person" learning. We are excited to see an improvement in our graduation rates!

In addition to our regular weekly programming, the TCAP Team invited members from the community to facilitate workshops for our students. During the Fall Session, the following workshops were provided to students:

- CFCC Executive Director and a volunteer TCAP judge, Aubrey Edwards-Luce, facilitated workshops on "Understanding How Trauma Affects the Body and Coping Mechanisms" for students of all ages.
- Three law students from the University of Baltimore School of Law, Bronfein Family Law Clinic, presented an interactive workshop on "Know Your Rights: Voting and the Police" with high school students.
- The TCAP Case Manager, Christopher Kelly, hosted a workshop on the high school choice process and how to select schools for middle school students.
- TCAP volunteer judge, Mark Friedenthal, a public defender, spoke to high school students about their rights when stopped by the police both on school grounds and in public.

 Students from the Baltimore Polytechnic Institute (Poly) partnered with Great Kids Farms and My Box to facilitate a workshop on climate change and gardening, "Global Gardens: Climate Change and You" for middle school students. Poly students also spoke to the middle school students about school choice and their own experiences at Poly.

CFCC is most grateful for the support we receive from state and federal funders, foundations, and individuals, among others. This support has allowed us to operate the TCAP in City Schools for the almost 20 years. Through the years, we have collaborated with countless organizations and programs to operate our program, including the Office of the Public Defender, the Pro Bono Resource Center, Disability Rights Maryland, Great Kids Farms, My Box, and the Family League of Baltimore City, to name a few. Through collaborative efforts, we are better able to support our students and families.

#### YOU CAN MAKE A DIFFERENCE FOR TCAP FAMILIES

Many of our TCAP families are food insecure and rely on the free breakfast and lunch that is provided at every City School. For the last two years, we have been providing Spring Break Food Baskets to these families, as a resource when the free meals are not available. We recently hosted a bake sale to raise funds to support our Spring Break Food Basket project, as well as any other items a family may require (e.g., alarm clocks, school uniforms, warm clothing). overview of how prevention is possible with federally funded programs already available to parents and caregivers. The event presented current programs that support families before they are in crisis and reduce adverse childhood experiences. Speakers included family and state leaders implementing and participating in prevention focused community-based solutions for families.

- March 6, 2024 Aubrey testified in support of HB 849 and SJ4. HB 849 would establish a Universal Basic Income program for transitionaged youth who are aging out of foster care. SJ4 would establish governmental responsibility and accountability for addressing student chronic absenteeism. Senator Carter, the sponsor for SJ4, committed to accepting CFCC's recommendation to change the resolution's language from addressing "truancy" to "chronic absenteeism."
- February 23, 2024 Shanta co-authored an op-ed with Shereen A. White, <u>50 years after</u> <u>the Child Abuse Prevention and Treatment</u> <u>Act, it's time to redefine child protection</u> <u>through a lens of equity and support</u>.

• February 21, 2024 - Aubrey shared her lived experience as a kinship caregiver as she testified in support of SB 708, a bill championed by Maryland DHS Secretary Rafael Lopez. SB 708 would align Maryland's law with the evidence that shows that children who are removed into foster care have better educational, social, and health outcomes when they are placed with kinship caregivers. The bill balances a "kin first" with the best interest of the child analysis and respect for parents' right to direct the care, custody, and control of their children ...continued on page 6

- February 16, 2024 Aubrey attended The National Foster Youth Institute's Black Youth Leadership Forum at the Library of Congress in Washington, DC. Members of Congress and community leaders took center stage to discuss legislative initiatives and the community organizing they are doing to help build up successful Black youth. Amanda Bertholf moderated a conversation around community engagement and uplifting youth. Speakers included Natasha Leake, Robert T. Stephens, Nancy Kay Blackwell, and Kenneth Ward.
- February 15, 2024 Shanta testified on two bills in the House of Delegates

   HB 644 which would require child protective agents to advise parents of their rights in child welfare investigations and HB 833 which would establish a presumption that a child is getting proper care and attention if their parent is enrolled in inpatient substance use treatment.

- February 12, 2024 Aubrey Edwards-Luce and CFCC Deputy Director Michele Hong attended a grant training with the Maryland Administrative Office of the Courts, a longtime funder of the TCAP, formally known as the TCP.
- February 8, 2024 Shanta, was featured in the ABA Journal article titled Adoption and Safe Families Act (ASFA), a topic which she recently published an article that argues for the repeal of ASFA.
- February 5 2024 Shanta presented her work in progress at Temple University, Beasely School of Law in Philadelphia, PA as a participant in the Faculty Research and Development Faculty Exchange Program.
- Jan 25, 2024 Shanta conducted a virtual training on the child's constitutional right to family integrity for the Montana Office of the State Public Defender.
