**58%** of respondents to a family court survey believe they should treat substance abuse disorders and addiction as a chronic disease.

**82%** believe early intervention is the most effective means to address substance abuse and addiction.

**88%** believe further training of family court professionals in substance abuse and addiction would be beneficial.

Often, substance abuse and addiction are major factors in family court proceedings, inflicting upon families and children the same destructive and debilitating consequences as they do on those involved with the criminal justice system.

**Yet the problem of substance abuse and addiction remains largely unaddressed in the nation's family courts.** Only 24% of judges and masters surveyed in Maryland ask court staff for information on an individual's use of alcohol and other drugs. Of those surveyed, 88% said that they would benefit from further training on substance abuse and addiction.

The University of Baltimore School of Law Center for Families, Children and the Courts has developed **The Benchbook on Substance Abuse and Addiction for Family Courts** to meet this need for additional training.

## ABOUT CFCC

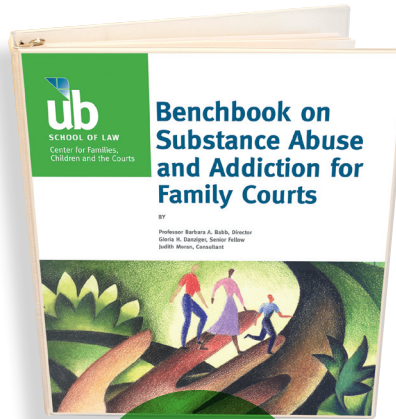
