

UNIFIED FAMILY COURTS

WHAT IS A UNIFIED FAMILY COURT?

A unified family court is a single court system with the authority to handle all cases involving children and families. Case types include divorce, custody, child support, marital property, alimony, adoption, paternity, domestic violence, child abuse and neglect and juvenile delinquency, among others. Unified family courts have the resources and ability to address both the legal and non-legal issues that arise in family law—from substance use and mental health issues to the impact of poverty and trauma.

A THERAPEUTIC JURISPRUDENCE APPROACH

With an approach to family law grounded in therapeutic jurisprudence, unified family courts have standards to resolve family law cases in ways that improve outcomes for children and families as a result of the courts' involvement. Unified family court judges bring to their deliberations a holistic understanding of the myriad challenges facing families and children and seek to serve each family's legal, personal, emotional and social needs. A unified family court draws upon a broad array of community resources to help families, with services that may include:

- Marital counseling for family reorganization in the event of divorce
- Parenting classes in high conflict custody cases
- Counseling and other treatments for families and individuals affected by substance use, domestic violence or other adverse events and circumstances

A unified family court is user-friendly and accessible to everyone, including the increasing numbers of self-represented litigants in the family justice system. The unified family court model increases court efficiency; provides for more coordinated and effective case processing and decision-making; and offers cost savings for clients, attorneys and the court system.

CFCC'S LEADERSHIP IN FAMILY JUSTICE SYSTEM REFORM

The American Bar Association has recommended since 1994 that all jurisdictions establish unified family courts. This court model also is endorsed by the National Council of Juvenile and Family Court Judges and the Association of Family and Conciliation Courts. Yet, many states have not adopted the model.

Professor Barbara A. Babb, CFCC's founder and director, was an early proponent for the establishment of unified family courts and continues to be a leading scholar and advocate for their creation and for the ongoing assessment of their operation. CFCC's website provides access to the extensive body of written advocacy for unified family courts which underpins CFCC's work.

Nationally and internationally, CFCC has provided in-depth consultation and hands-on assistance to state and local courts about implementing and evaluating a unified family court model. For example, CFCC has played an instrumental role in transforming the family justice system in Maryland, helping to create and launch the Family Divisions and authoring *Performance Standards and Measures for Maryland's Family Divisions* (Maryland Judiciary, 2002). In addition, CFCC has provided services to jurisdictions in California, the District of Columbia, Florida, Indiana, Louisiana, Michigan, Nebraska, New Mexico, Ohio, Pennsylvania, Tennessee and Utah, among others. Internationally, CFCC has inspired and influenced the development of unified family courts in Ontario, Canada, and Singapore.

A BLUEPRINT FOR A UNIFIED FAMILY COURT

Professor Barbara Babb's scholarship outlines a blueprint for a unified family court, which includes the following key features:

- A specialized court structure—either a separate court or a division or department of an existing court—established at the same level and receiving the same resources as a trial court of general jurisdiction
- Comprehensive subject-matter jurisdiction over the full range of family law cases, including juvenile delinquency and child welfare
- A case management/processing system involving early, hands-on and continuing contact with each family law case
- A judicial assignment system where the family appears before one judge for the resolution of the entire case, where the same case management team coordinates the family's case each time the family utilizes the family justice system or where the same judge hears the family's case each time the family appears in court
- An array of court-supplied or court-connected social services that meet the family's and children's non-legal needs related to their family law issues
- A user-friendly court accessible to all family law litigants, including selfrepresented litigants

The first issue of CFCC's <u>Unified Family Court Connection</u>, published in 2007, focused on the nationwide support for unified family courts and a blueprint to establish them, an ongoing principal passion of CFCC's work.

CASE STUDY:

A UNIFIED FAMILY COURT PILOT FOR DOUGLAS COUNTY, NEBRASKA



In projects ranging from presentations to attorneys and judges to in-depth feasibility studies, CFCC works with jurisdictions across the country and around the world to develop standards, implement procedures and evaluate

the performance of unified family courts, problem-solving or specialty courts and attorney practices.

CFCC's 2019 report to Douglas County, Nebraska, consisted of a series of recommendations for the development and implementation of a unified family court pilot project, now under consideration by the court. The work plan included:

- Review of Current Court Operations: CFCC reviewed the current Douglas County Separate Juvenile, District and County Courts' structures and operations, including case management systems, resource allocation, forms, written procedures and data collection.
- Site Visits and Stakeholder Engagement: CFCC conducted a three-day site visit that included court observations, an educational session about unified

family courts, individual meetings with court leadership and multiple listening sessions with stakeholders.

- Survey: CFCC, in collaboration with Nebraska Court Improvement Program staff, developed a survey designed to identify significant practices and opinions related to court handling of matters involving Douglas County's children and families, and they analyzed extensive survey results.
- Unified Family Court Forum: The CFCC team designed and convened "A Forum on the Douglas County Unified Family Court Pilot" in Omaha, attended by more than 150 judges, court staff, attorneys and service providers.
- Site Visit by Nebraska Team to Maryland: Douglas County representatives visited with Maryland court system leaders in Baltimore and Annapolis to learn about the Maryland's Family Divisions' structure and operation.
